Words & What They Mean

Advocate: An advocate will talk to someone privately about if they have been hurt sexually.

Sexual Violence: Any unwanted or forced sexual touching or activity. It can be:

- Brushing against the person in a sexual way
- Forced kissing
- Taking clothes off without asking
- Making a person look at pornography
- Making a person look at sexual acts/touching they are not comfortable with

Sexual Harassment: Any comment, gesture, or sexual hint that is unwanted.

Human/Sex Trafficking: When someone is sold, used, or forced into doing sexual things for others.

Advocacy: Giving support and help to someone.

Domestic Violence: Abuse within a personal relationship wherein the abuser has power and control over the person. An abuser can be a husband, wife, partner, a boyfriend or girlfriend, a family member, or a caregiver.

Domestic violence can include:

- Physical abuse (hitting, shoving, etc.)
- Emotional abuse (name calling, yelling, etc.)
- Misusing a person's money
- Taking away things needed to survive like medicine, talking machine, wheel chair, etc.
- Making threats
- Breaking or destroying property

Crisis Line/Crisis Line Advocate: A crisis line is an emergency phone number that you can call. A crisis line advocate is the person who answers the phone when you call. A crisis line advocate will talk to you privately. You do not have to say your name, phone number, or where you are located in order to talking to a crisis line advocate.

Perpetrator/Abuser: A person who hurts or abuses. Perpetrators can be male or female, and can be of any age, race, religion, rich or poor, gay or straight. Very often, an abuser is someone you know, not a stranger.

Victim/Survivor: A person who has been hurt by sexual violence. A survivor or victim can be anyone.

Mandated Reporter: Certain people who must report any abuse they suspect you are experiencing to the police or protective services.

Consent (freely given): Consent is when someone gives permission. Consent can be a "yes". Freely given means:

- No lies
- No threats
- No force
- No bribes
- No tricks
- No pressure
- No guilt

You must ask someone before touching them or starting any sexual activity. Both people should be free to change "yes" to "no" at any time.

This can mean:


- Rape

If you have been hurt sexually, it was not your fault!


CMSAC services are here to help you.

CMSAC advocates can sometimes meet you at other places besides our Center to be more accessible. Sexual violence can happen to anyone, anywhere. It does not matter your:

- Age
- Ethnicity
- How much money you make
- Life choices
- Religion
- Culture
- Sexual identity
- Gender
- Ability

Sexual violence can be scary, embarrassing, and confusing. CMSAC has services to help <u>all</u> survivors of sexual violence. CMSAC does not judge you and can help you make decisions about what to do about sexual violence.

Services CMSAC Can Help You With:

One-to-One Support Counseling

 You can work with an advocate to learn about sexual violence and how to heal from hurtful things that may have happened to you sexually.



Education

 You can work with an advocate to learn about consent, healthy relationships, safety, and other topics.



Support and Education Groups

 You can join groups with other survivors to learn about sexual violence and how to support each other to heal.



Human Trafficking Services

 You can work with an advocate to learn about how trafficking is a kind of sexual violence. You can talk about how being trafficked has hurt you and how to heal.



Help for People in the Sex Industry

 If you have been a part of strip clubs, pornography, exotic dancing, or escorting, you can work with an advocate to learn about safety, how the sex industry has hurt you, and how to heal.



Safety Planning

 You can work with an advocate to talk about your safety and how to make a plan to help keep you safe.



"Safe at Home" Program

 An advocate can help you fill out forms for a private mail address to help keep you safe.



Harassment Restraining Orders

 An advocate can help you fill out forms that can help you stay safe from someone who is harassing you or will not leave you alone and makes you feel scared.



Orders for Protection

 An advocate can help you fill out forms that can help you stay safe from someone who is close to you that may be hurting or scaring you. This could be a family member, boyfriend/girlfriend, husband/wife, or others.




Criminal Justice Advocacy

 An advocate can help you talk to police about making a report about a sexual assault or sexual abuse.



Hospital Advocacy

 If you need to go to a hospital because of a sexual assault or sexual abuse, an advocate can meet you there and help you.



Professional and Community Education

 Advocates from CMSAC can help professionals and members of the community learn about all kinds of sexual violence.



Referrals to Supportive Services

 You can ask an advocate about other kinds of services like therapy, housing, or transportation, and they can help you get information.
