# Men Accountable for Sexual Exploitation

## Program

### Mission:

*To reduce all forms of commercial sexual exploitation through an accountability-focused program for men who have solicited commercial sex*

### Program Outcomes:

Participants will...

- hear testimonies from local survivors about the impact of men's sexually exploitative choices
- receive information on the realities of the sex industry, prostitution, pornography, and trafficking
- understand the attitudes, behaviors, and social forces that lay the foundation for male violence and abuse
- learn to recognize and interrupt their individual decision-making process to prevent further exploitation
- receive resources and referrals

### Enrollment Process:

3. Call CMSAC during business hours (Monday-Friday, 8:30 a.m.- 4:30 p.m.) at 320-251-4357 to confirm we have received your intake and to confirm there is still space for you to enroll in the next class. Intake and down payment MUST BE RECEIVED no later than 4:30 pm the Friday before the scheduled class; any intakes received after the deadline will be enrolled in the following class.

**Your confirmation call and \$200 down-payment will officially register you for the class**

*\*Please note: MASE is an equivalent to other "John Schools"/demand reduction programs across the country. MASE is not intended to be a diversion program to escape charges.*

*This class is for those charged with purchasing/soliciting sex – this class is NOT for those charged with trafficking/aiding in trafficking*

*The cost to attend MASE is \$900. Proceeds will fund victim services for survivors of sexual violence and exploitation served at CMSAC*

<b>Referrals</b>	CMSAC will take MASE referrals from any county.
<b>Date</b>	See website for next scheduled date at <a href="http://www.cmsac.org/mase">www.cmsac.org/mase</a>
<b>Time</b>	9:00 a.m. – 5:00 p.m. <b>Arrive before 9. You will not be admitted if you are late.</b> Allow plenty of time to find the building, park, and locate the room. Lunch break will be from 11:30-12:00. We will eat on site. <i>Due to the limited amount of time, we recommend bringing your own bag lunch.</i>

<b>Class registration</b>	After your \$200 down payment has been sent, call CMSAC during business hours (Monday-Friday, 8:30 a.m.- 4:30 p.m.) at 320-251-4357 to confirm that we have received your intake and payment. Partners/spouses or parents may not call on your behalf. <u>Your down payment, completed intake, and confirmation call will officially register you for the class. Your spot will not be held without the down payment.</u>
<b>To bring to class</b>	Picture ID \$700 money order/cashier's check payment ( <u>no</u> other payment methods are acceptable) Bag lunch
<b>Attire</b>	No hats, sunglasses, clothing deemed inappropriate by facilitators, etc.
<b>Behavior</b>	Your genuine participation and engagement is encouraged. Comments, jokes, or language deemed by facilitators to be sexist, abusive, or derogatory in nature will not be tolerated. Cell phones must either be left in your car or completely turned off. If you are seen checking your cell phone at any time (except breaks or lunch), or the ringer goes off, you will be asked to leave. If you are asked to leave, for any reason, you will not receive a certificate of completion and you will be required to pay a new fee to take the class again.
<b>Class Completion</b>	You will receive a certificate of completion after the end of the class. It is your responsibility to provide proof of your MASE completion to your probation officer or attorney.
<b>Class Cancellation</b>	Occasionally class may be cancelled due to not enough participants registered or other unforeseen circumstances. You will be notified by email or phone if this occurs as soon as possible before the class. Cancellations are also listed on our website on the MASE tab. If cancelled, you will automatically be re-enrolled for the next class.
